An opportunity is being provided for your son in Year 12 2017 to complete the **RSA (Responsible Service of Alcohol Course)** and the **RCG (Responsible Conduct of Gaming Course)** at Holy Cross College at a reduced cost. By law, any person wishing to work in licensed premises, e.g. Clubs, Hotels and Restaurants must have completed these courses. The RSA and RCG will be held at Holy Cross College on the following dates:

Upcoming School Holidays (Week 1):

Friday 29 September 2017 9:00am-3:00pm RSA Course

RSA Course- 6 hours face-to-face with a qualified NSW Office of Liquor, Gaming and Racing approved RSA Trainer.

Term 4:

After HSC (on a date to be confirmed) 9:00am-3:00pm RCG Course

RCG Course- 6 hours face-to-face with a qualified NSW Office of Liquor, Gaming and Racing approved RCG Trainer.

The cost is \$180 per student to complete both the RSA and RCG qualifications. There is the option of completing the RSA Course only for \$110. There is also the option of completing the RCG Course only for \$70. These fees must be paid by **Term 3 Week 10 Wednesday, 20 September 2017** to the Bursar's office as **numbers need to be finalised on that day**. Please note that your son can complete these qualifications prior to being 18 years old but he will be unable to use these qualifications for employment until he is 18 years old.
